
## Packaging :

## PPE subject to ageing :

Peremption period : After 5 years of use, it's preferable to change your gloves after the first use when stored in appropriate conditions (humidity, temperature, clean , ventilated, light). Before use, the glove shall be visually controlled, in case of deterioration the gloves must be scrapped (abrasion, cut, tear, ...).

## MEANS OF CONTROL



\* Physical tests: leather density and thickness tests and tear strength tests according to EN ISO 3377-1:2011.  
Chemical tests (Ph - ISO 4045 / Chrome 6 - ISO 17075 / Azo - ISO 17234).  
We proceed to these tests for each production process, once leather is sourced and before the cutting process.
